at a Board Meeting called to Order

for the Purpose and ~~the~~
of an Agreement for the Expenditure
of the Highway Money

This Agreement entered into this 18th
day March 1911 by and between
Fred Hummer Town Superintendent
of the Town of Boston N.Y.

and the Undersigned Members of the Town
Board of the Town of Boston County of Erie
constituting a Board for the Purpose of
determining the Places where and the
Manner in which the Money Levied and
collected in said Town and received
from the State as State Aid shall be
expended for the Repair and
Improvements of Highways
it is agreed that we hereby set aside for
the General Primary Work upon the Highways
in said Town an average sum of
Twenty Dollars (20.00) Per Mile for 7.2
Miles which is the Total Mileage of Highways
within the Town

It is agreed that we set aside for the
Repair and Construction of Sluices Culverts
and Bridges having a span of less than five
feet and for the Renovation water Brakes
Eight Hundred (800.00) Dollars

it is also agreed that we set aside the following
sums for the Permanent Improvement of Highways
exclusive of Sluices and Bridges having a span
of less than five feet but including tile
Drainage at such Points as may be Directed
by the County Superintendent Upon the following
Named Roads
On the Road Commencing at Wittmeyer House
Mill St. and leading to B. S. R. R.
a Distance of 1/2 Mile there shall be Expended
the sum of 75.00

No 2 B. S. R. R. at Boston Road leading to
Boston Village Distance 1/2 Mile 75.00
Commencing at

No 3 North Boston Back Road and Leading to
Boston Village Improvement with Gravel 200.00
a distance of 4 Miles

No 4 Commencing at Eighteen Mile Creek Shero Road
and Leading to Kaufman Hotel a distance of
1/2 Mile Improvement with Gravel 50.00
